Jonathan Robinson: Thank you, Glen. And very warm welcome to the seven new councilors. And I think if I say that really warmly you might vote for me as chair.

Carlos Gutierrez: Sorry, Chair, Carlos Gutierrez is also present.

Glen de Saint Géry: I'm very sorry, Carlos.

Jonathan Robinson: Welcome, Carlos. So we would normally review - well we should just make note that I would just like to either note that I see there's a link to each of your Statements of Interest so that's great. Is there any update to those since they were filed? Is there anything you'd like to say to update those? I'd imagine they're all relatively recently filed.

Okay, hearing none, so we have at this point only one item apart from any other business and that's the chair election procedure. Is there anything else that should or could be on the agenda? Seeing none I'll hand over for Item 2 to my vice chair, David Cake, to our vice chair, David Cake, for - to run the election of the chair procedure.

David Cake:

Right. So as everyone is aware we have an election for the chair. We have only one candidate but you can - we can still choose to vote for None of the Above. So I am going to ask Jonathan - if anyone has questions for the candidate? Oh first do you wish to make a statement to the Council?

Jonathan Robinson: No I feel - thanks, David. I think we covered things off pretty well in the weekend session. I am willing to answer any other questions or supplementary points but we went through things in the run up to - in the weekend session so unless there's something additional it's not necessary to say any more. Thanks.

David Cake: Okay, in that case I would like to ask if any of the councilors have a question for the candidate. Yes?

James Bladel: So this is kind of pro forma since you're running unopposed and my vote is probably already set and sealed. But I do have a question just in terms of, you know, your leadership to this point of this body and your plans going forward.

I think that there is a shift underway perhaps in the community as other elements of the community try to essentially assert themselves as either separate or above the GNSO Council, particularly when it, you know, when it comes to policy decisions that they believe to be affecting them.

And I'm wondering how can you - how do you anticipate, you know, as the person that's kind of the voice and the face of the GNSO Council, do you anticipate that this will also increase and how do you plan to address that in the coming term?

Jonathan Robinson: That's a good question, James. And especially if my answer can turn it from a probably into a certainly. But, no, I think I actually feel we're in a better place then we were a year ago. I mean, I think it's not to say we should be complacent but I - my sense is from - certainly from the Board and, I mean, when we met with the Board on the weekend many people afterwards came out to me and said that was the best meeting we've had with the Council in a long time or perhaps the best one I remember.

And in my view that's really the best way of getting them to what we've called respect the policy bodies and the policy process. I think for quite a while we were certain of our place constitutionally but less certain of our kind of moral high ground if you like. We were not seen to be a trustworthy place necessarily or we didn't have a good profile.

So I think my sense is we are - it is now appreciated and we should continue to assert our role, make no mistake. I'm not in any way suggesting we shouldn't be - continue to be assertive and clear on the role and function of the Council, the role and function of the groups within the GNSO. But I think we've come a long way in reasserting that. And so I feel that that's something we've just got to continue to work at.

But I don't think we should be coming at it from a defensive position, I think we should be confident that actually we're in not a bad place at

the moment but that doesn't mean, like I said at the beginning, we

should be complacent.

James Bladel: Thank you. And I look forward to helping you with that.

Jonathan Robinson: Appreciate that, James.

David Cake: Do we have any other questions? Okay there being no other questions

I guess we will move directly to the election.

David Cake: Yes. Now the election according to GNSO Operating Procedures, this

is a secret ballot so councilors will be handed a ballot by Glen. While

she is handing those out I'll just note that in - within our - the house

structure we've already had elections for vice chair and both Volker

Greimann and myself have been returned for a second term as vice

chair so presuming we reelect Jonathan we'll have the same Council

leadership team for this year.

Jonathan Robinson: So, Glen, if we can note for the record when you get back to your

seat that Volker Greimann is present.

Glen de Saint Géry: So we'll just wait a few minutes while the votes are being tallied by

Rob Hogarth.
