



#### Verified Trademarks Submitted into the Clearinghouse



#### Sunrise Periods

Through Sunrise periods completed: **269** 9 Oct 14

Sunrise periods in process: **35** 

Highest reported Sunrise total: **713** 

Average Sunrise transactions per TLD: **118** (based on 228 TLDs)



#### **Trademark Claims**

Through Claims periods completed: **162** 9 Oct 14

Claims periods in process: 97

Through Claims notices sent: **6,361,411** July

Cumulative Claims transactions: 60,735

Average Claims transactions per TLD: **299** (based on 228 TLDs)
